PROCESS of E-Tender:

Vendors are required to register themselves online with www.mstcecommerce.com. Registered Vendors are to submit EMD & other required information to Senior Manager (Purchase), Tea Division, ANDREW YULE & COMPANY LIMITED, Kolkata.

The process involves Electronic Bidding for submission of Techno Commercial Bid as well as Price Bids. The vendors will have to submit the General Information, Earnest Money deposit as per tender document, confirm acceptance of technical specification and provide technical details as per Tender Document within the schedule date as mentioned above. 5. Liquidated Damage
In the event of failure on the part of the contractor to complete entire work against the order to our full satisfaction within the specified period of completion, we may recover from the contractor as liquidated damages, a sum equivalent to ½% of material value for each week or any part thereof default, where the delivery thereof will be accepted after expiry of the date stipulated for this purpose, but limited to a maximum of 10% of material value
6. Force Majeure
Any delay or failure in the performance of either party hereto will not constitute default thereunder or give rise to any claim for damages, if any, to the extent such delays or failure of performance is caused by the occurrence such as acts of god or the public enemy, appropriation or confiscation of facilities by Govt. Authorities, acts of war, rebellion or sabotage, fires, explosions, riots and illegal strike.
7. Risk Purchase
In case the contractor fails to execute the contract fully or partly, the purchaser shall have the right to execute the work through other agencies, as decided by the purchaser at the contractor's cost and risk after giving two weeks notice in writing.
8. Terms of payment
 - a) 15% of material value as advance against Bank guarantee of equivalent amount. The Bank guarantee will be released on receipt of entire material at site.
 - b) 75% of material value alongwith 100% Taxes, Duties, Freight & Insurance Charges within 15 days of receipt of material at site duly certified by the Manager.
 - c) 90% payment towards installation and commissioning charges will be made within 30 days from the date commissioning / handing over duly certified by the Manager.
 - d) Balance 10% of project value within 30 days from the date of commissioning / handing over duly certified by Manager against Bank guarantee of equivalent amount valid till guarantee period.
 - e) Statutory deductions will be made as per rules.
9. Price Variation
The quoted price should remain firm during pendency of the contract.
10. Guarantee
12 months from the date of commissioning / handing over against defective material and faulty workmanship. Defective goods/material or parts returned by the Purchaser to the

Seller shall be replaced by the Seller at Seller's expenses. This guarantee shall survive and hold good notwithstanding, inspection, payment for and acceptance of goods. The Seller will depute suitable technical persons at their cost in the event of any problem during operation.
