PROCESS of E-Tender:

Vendors are required to register themselves online with www.mstcecommerce.com/eproc. Registered Vendors are to submit EMD & other required information to Senior Manager (Purchase), Tea Division, ANDREW YULE & COMPANY LIMITED, Kolkata.

The process involves Electronic Bidding for submission of Techno Commercial Bid as well as Price Bids. The vendors will have to submit the General Information, Earnest Money deposit as per tender document, confirm acceptance of technical specification and provide technical details as per Tender Document within the schedule date as mentioned above.
