**Sub: Notice for Special Spot e-Auction 2020 for Import Substitution (Only for Coal importers) (Feb '21 to July '21).**

Any Indian buyer including traders who imported coal at any point of time in the current year and/or any of the previous two financial years are hereby informed that Special Spot e-Auction for Import Substitution (Only for Coal importers) 2020 is **scheduled to be held on 02.02.2021 through M/s MSTC Ltd.** Schedule of dates of the said auction is as under:

The **Special Spot e-Auction 2020 for Import Substitution (Only for Coal importers) (Feb'21 to July'21)** will be conducted as per the scheme for Special Spot e-Auction 2020 for Import Substitution (Only for Coal importers), with all modified modalities circulated by CIL vide Notice No- CIL/M&S/SSEA-IMS/312 dated 12.08.2020, Notice No-CIL/M&S/SSEA-IMS/423 Dated 05.10.2020 and Notice No-CIL/M&S/SSEA-IMS/424 dated 05.10.2020. The Basic eligibility criteria for the prospective consumers shall be as per the Special spot e-auction scheme 2020 for Import Substitution. In line with the above, the additional modified modalities for **Special Spot e-Auction 2020 for Import Substitution (Only for Coal importers)** will be as follows:-

1. Bidders after successful bidding will give a declaration to BCCL on distribution of quantity in twelve monthly instalments (for Road mode) and six monthly instalments (for Rail mode) for February '21 to July '21 within 7 days of auction. However, distribution can be re-casted if needed, based on mutual consent of buyer and seller.
2. In case of non-submission of distribution of monthly quantity for February '21 to July '21 by the bidders, BCCL will distribute the booked quantity in equal monthly instalments for road mode and as per the Special Spot e-Auction for Import Substitution 2020 scheme for Rail mode.
3. The minimum quantity for bidding would be **24000 (Twenty four thousand) tonne for any mode** (i.e. 24000 tonne for road mode source & 24000 tonne/6 rakes for Rail mode source).

4. Increment of bid in Rail mode shall be 4000 tons (1 rake) load and in Road mode it shall be 1000 tons. The rake size shall be as per prevalent Railway Rules.
5. EMD shall be at the rate of Rs.200/-per tons of all grade coals. EMD can be deposited in form of e-transfers/bank draft/banker's cheque /bank guarantee.
6. Applicable price on the date of despatch of coal would be variable in line with the changes in the notified price of CIL/BCCL, i.e. the percentage increase over the reserve price at which the bid is clinched, shall be applicable over the revised reserve price arising out of price revision, if any, on the date of despatch. However, any changes in the methodology/guiding principle for determining the reserve price in subsequent days would not be applicable for revision of current method of determining the reserve price, except for change in the notified price as mentioned above.
7. Payment of coal value for supply in a month for road mode to be made on monthly basis in two instalments as per bidder's choice. Schedule of coal value deposition by Road & Rail mode would be as under:-
