



3. In addition to price of coal other add on prices if any will be recovered, statutory charges and Govt. levies will be charged as applicable on the date of delivery.
4. Before participating in e-Auction bidders must satisfy themselves the quality of the coal being offered from the source no complaint thereafter (i.e. after the auction) will be entertained by the JSMDC Ltd.
5. In addition to above Royalty, GST, GST Compassion Cess, Handling Charges, Evacuation Facility Charges and any other charges as applicable will have to be paid by buyers at JSMDC Ltd.
6. The refund shall be made only to the A/c No. and the Bank through which the coal value will be deposited and as per e-mandate provided by the customer to JSMDC Ltd.
