What is Vigilance Angle?



Demanding and/or accepting gratification other than legal remuneration.



Obtaining valuable thing, without consideration or with inadequate consideration from a person with whom he has or likely to have official dealings.



Obtaining for himself or for any other person any valuable thing or pecuniary advantage by corrupt or illegal means or by abusing his position as a public servant.

Possession of assets disproportionate to his known sources of income.



Cases of misappropriation, forgery or cheating or other similar criminal offences.



Other things which may have a vigilance angle



Gross or wilful negligence, reckless decision making, blatant violation of system and procedures and excessive discretion



Any undue/unjustified delay in the disposal of a case, perceived after considering all relevant factors.

How to report corruption and Where?



Lodging of Complaints

Do's

- ✓ Complaint must contain factual details, verifiable facts and related.
- ✓ Complaints sent on email should contain postal address (mobile / telephone number, if any) of the sender.
- ✓ If the complaint is received against e-auction/e-tender, the matter would be investigated, however it would not interfere in the e-auction process as such.

Don'ts

- ✗ Complaint should not be vague or contain sweeping general allegations.
- ✗ Redressal of grievances should not be the focus of the complaints.
- ✗ Anonymous/Pseudonymous complaints shall not be entertained.

Whistle Blower Complaints

If a complainant while exposing a case of corruption wants his identity to be kept secret, he/she should lodge a complaint under Public Interest Disclosure and Protection of Informers Resolution (PIDPI) – popularly known as Whistle Blower Provision.

- ✓ Complaint under “Public Interest Disclosure and Protection of Informer” Resolution can be made only by post. The envelope should be superscribed “PIDPI” or “Whistle Blower”.
- Complaints under PIDPI should contain name and complete postal address of the complainant. Such details shall be kept confidential by the authority

- ✓ CVC is the designated authority to receive PIDPI complaints. Such complaints are to be addressed to

Whistle blower complaints can also be addressed to CVOs of respective Ministry.
