- v. Despatch process (loading, weighment & transport in washery premises) shall be done under CCTV surveillance
- vi. Dispatched quantity shall be shown while submitting monthly/Annual Report.
- vii. The approval does not supersede any restrictions imposed by any Govt. agency.
- viii. A line of confirmation shall be communicated within 15 days from the date of receipt of this letter.
